J78/21 ELECTION OF CHAIR: Keith Tilley was nominated (Cllrs BB-C/PR) and following a vote, Council RESOLVED to recommend to Full Council the election of Cllr Tilley to the role of Chair.

Committee **NOTED** the report and the following actions were agreed:

#### J86/21 PUBLIC TOILETS: LITTER BINS INSIDE THE UNITS.

Committee **NOTED** there are no bins in the toilets and **AGREED** to ascertain the feasibility and costs of installing litter bins.

Action: DTC to contact the public toilets maintenance contractor.

#### J87/21 LANDSCAPE MAINTENANCE; AREAS MISSED DURING SCHEDULED CUTS.

Committee **NOTED** reports by Cllrs BB-C and PR that grass and shrub areas in Fullers Slade and Galley Hill have not been cut during scheduled maintenance rounds and **AGREED** that Cllr PR would provide DTC with specific areas missed and Cllr BB-C undertake a Ward walk of Fullers Slade with DTC.

Action: Once the information has been gathered DTC to contact the landscape maintenance contractor about missed areas.

#### J88/21 NEWLY INSTALLED HORSEFAIR GREEN DOG BIN.

Committee **NOTED** complaints by some parishioners about the location of the bin.

Committee further **NOTED** the May Full Council meeting **AGREED** to the monitoring of the

bin usage and condition and reports to be presented to Projects June and July meetings. Committee **AGREED** the report should be compiled over a number of weeks and be presented to July Projects Committee.

Action: DTC to ask the bin contractor for weekly feedback reports.

#### J89/21 8. PROJECTS REGISTER UPDATE.

Committee **NOTED** the updates and the following actions were agreed:

#### J90/21 073/DTC/0321 FREE-STANDING DOG FOULING SIGNS ON SPIDER PARK.

Committee **AGREED** that Cllr BB-G and DTC would meet on site to identify specific proposed locations exactly, and DTC would forward the information to MKC for permission to erect the sign. Committee **NOTED** MKC has provided suggestions of external signs companies and **AGREED** that costings and designs be presented to July Projects Committee.

ACTIONS: CIIr BB-C and DTC to meet on site; DTC to research signage options.

REMOVE: 'and subject to prior notification of their intention to speak on a specific matter being given to the Proper Officer' REASON: Members of the public do not have to give prior notification to attend and speak at Parish and Town Council meetings.

### J93/21 11. ACCESS TO FOOD BANKS/COMMUNITY LARDERS.

Committee **NOTED** the invitation from Great Linford Parish Council to join their community larder scheme, and **AGREED** that, whilst it is a good scheme, the collection point at Downs Barn is some distance from Stony Stratford Parish. Committee **NOTED** that Wolverton and Greenleys Town Council run a community fridge scheme and **AGREED** that they be approached for possible collaboration. Committee also **AGREED** to undertake research into the feasibility of setting up a similar community larder scheme within Stony Stratford parish.

Action: Cllr BB-C to contact WGTC Community Fridge and research the feasibility of setting up a similar local scheme.

#### J94/21 EVENTS WORKING GROUP UPDATE.

Committee **NOTED** the update report from Cllr KT: There are no current plans to hold Apple Day 2021. The final decision is pending further Covid-19 restriction changes.
