Committee **NOTED** the report and made the following decisions:

P022/22 Proposed Works to Bus Stop Wolverton Road:

Committee AGREED the following actions:

- 22.1 Response to MKC request for SSTC view on how long the waiting time in the time limited parking bays should be: Committee **AGREED** 15 mins, as per the nearby parking bays. **Action: TC to submit response**.
- 22.2 Response to MKC regarding electric charging points Committee **AGREED** that electric charging points would not be appropriate due to the limited waiting time.
- 22.3 Cars parking on the pavement: Committee **NOTED** with disappointment that the issue of cars parking on the pavement could not be dealt with by the MKC Passenger Transport Team and their advice to report the matter to MKC Highways. Committee **AGREED** that Highways should be contacted to report the matter. **Action TC to report**

P023/22 Additional Planning applications due for decision prior to the next meeting (under TOR) Committee AGREED

- 1. that an extension of time (EOT) should be sought for applications 22/00404/FUL and 22/00405/LBC 107 High Street. **Action: TC to seek EOT from the MKC Case Officer**
- 2. that the applicant should be informed the application will be discussed at the March Planning Committee meeting. *Action: TC to inform applicant*

P024/22 Crosshills Green Space Tree Planting Scheme

Committee **NOTED** the scheme which had been worked on by residents and the MKC Tree Officer and **AGREED** they had no concerns.

P025/22 Request for Bench or plaque on Horsefair Green

Committee **NOTED** the MKC (who own the existing benches) Landscape Manager response that MKC had no issue with a plaque going on one of the old benches as long as it wasn't on an existing memorial bench. Unfortunately, a new bench couldn't be installed as the MKC memorial bench scheme was not live due to technical issues with payment. Committee **AGREED** that the TC should inform the member of the public accordingly and ask that lit candles should not be placed on the

bench or any memorials due to the Health and Safety risk. *Action: TC to contact member of the public accordingly*

P026/22 Wolverton and Greenleys Town Council (WGTC) request for Council to look at CCTV on the Redway between FS and Greenleys.

Committee **NOTED** that WGTC had installed CCTV at their end to some success. Committee **AGREED** that:

- the TC should contact Thames Valley Police and Milton Keynes Council to see if they would agree to install temporary CCTV to compliment the WGTC effort. Action: TC to contact MKC and Thames Valley Police
- 2. It was not in favour of borrowing the CCTV.

P027/22 Higlin's Piece – request from resident to seek listing the area on the Heritage England register (Ref: EH HEAG238 – Agricultural SSG) due to the ancient ridge and furrow (apparent on the LIDAR map).

Following some discussion, Committee **AGREED** to thank the resident for their diligence and seek advice from the MKC Conservation and Archaeology Officer. **Action: TC to contact MKC and the Resident.**

P31/22 MKC CONSULTATION: Draft Local Cycling and Walking Infrastructure Plan consultation
Committee NOTED and thanked the TC for outlining the areas of particular interest. Following discussion, Committee AGREED that the following be included in the response which would then be reviewed by the Chair and TC prior to submitting:

- 1. Referring to the Stony Stratford Made Neighbourhood Plan Part 12 which deals with accessibility and connectivity.
- 2. Refer to the overarching aims of the Stony Stratford Neighbourhood Plan which the aspirations are to 1. Work with MKC on a Programme of improvements for walking, redways, pedestrian crossing and cycling and 2. Extensions of the Redway network into and within Stony Stratford, crossings and cycle parking facilities.
- 3. MKC suggestion of Wolverton Road/London Road Redway which comes to a halt being extended to go down Clarence Road rather than London Road as it is quieter: this might not be suitable due to the parking on both sides of the road and there might need to be adjustments to facilitate resident's parking.
- 4. To finish the incomplete Redway at Hayes Wharf which ends at London Road
- 5. Wolverton Road Recreation Ground to include a central refuge for emerging pedestrians/cyclists.
- 6. New Red Way from Ostlers Lane to Queen Eleanor Street (where there is currently no footpath making access very difficult for pedestrians or cyclists) which could then link to Magdalene Close and High Street, Church and ultimately the Nature Reserve.
- 7. Apollo Avenue currently the Redway comes to within 10ft of the Redway to Latimer
- 8. H1 to Tudor Gardens complete this Redway as per the Neighbourhood Plan aspirations
- P32/22 NEIGHBOURHOOD PLAN (NHP): revisions to the implementation (Action) plan
 Committee AGREED that the TC to recirculate the NHP Implementation plan prior to the March
 meeting and seek comments. Action: TC to recirculate

P33/22 HIGH STREET DESIGN PROJECT

Committee **NOTED** the report and after some discussion, **AGREED** that the final report should go to Full Council for consideration prior to the public consultation. **Action: TC to bring forward to Full Council.**
